

# CONDITIONS OF RESERVATION AND SALE OF A STAY IN A MOBIL HOME

## HOURS AND DAY OF ARRIVAL AND DEPARTURE :

Out of July and August: 3 nights minimum rental, arrived between 14 and 19 H, departure between 8 and 10 H

In July and August: 7 nights minimum rental. Arrive on Saturday from 14 to 20 H, departure Saturday from 8 to 10 H.

## OCCUPATION OF MOBILE HOME :

- to preserve the peace and quiet of the campground, groups are not accepted.
- minors who are not accompanied by their parents are not accepted.



a car and 4 persons for Mini mobile homes without bathroom and for "Mobil home A" or 5 persons for the "mobile home B". The setting up of an additional tent is prohibited. **Animals are not allowed in the mobile homes.**

**DEPOSITS :** 300 € (guaranteed material) + 70€ (guaranteed cleaning)

**Part or all deposits will be refunded upon departure, after returning the identity bracelets, keys, checking the inventory and the cleanliness of the mobile home and noticing possible damages.**

Deductions shall be fixed or estimated depending on the extent of the damage. Fixed deductions :

## BOOKING :

: Bookings are not transferable. Under no circumstances may they be transferred or sub-let.

If there is any change to holiday dates, we cannot guarantee to provide the same rented accommodation.

**The reservation of a stay in a camping site becomes effective only upon our agreement and after receipt of the reservation contract with the requested deposit of 30% of the Total price of the stay, the reservation fee and the insurance cancellation (optional, but advised) .**

Payment methods available : **banker's card, bank transfer.**

**PAYMENT OF THE BALANCE : The payment of the balance is payable in full 1 month before the beginning of the stay (banker's card or bank transfer).**

the customer will then receive the discharged invoice of his stay. The customer not having paid the balance as of the agreed date, is regarded as having cancelled his stay and no refunding will be carried out.

**RESERVATION LATE :** in the event of reservation less than 1 month before the beginning of the stay, full payment will be required.

## IN THE EVENT OF CANCELLATION :

**Because of the customer :** Booking fees and insurance cancellation (optional, but advised) are never refunded.

You will be reimbursed :	No insurance	With insurance
More than 30 days before the arrival :	Deposit - 30%	25% of the amount of stay*
Less than 30 days before the arrival :	0	Set sum*
Interruption stay :	0	Refund of remaining stay*

\* Provided the reason of cancellation or interruption is covered by the insurance. (see additional document)

**Because of the manager of the camp-site :** cancellation before the beginning of the stay will be notified to the customer by registered letter with acknowledgement of delivery. The customer will be immediately refunded versed sums. These provisions does not apply when he is concluded a friendly agreement having for object acceptance by the customer from a stay of substitution suggested by the camp-site.

**he ARRIVAL :** The customer must present himself the specified day, at the hours mentioned on his confirmation of reservation. In the absence of any message from the signatory of the contract, stating that he has had to postpone his arrival date, the Mobil home available for hire 24 hours after the arrival date stated on the booking contract.

## THE STAY :

: All campers must abide by site regulations. The customer is responsible for all the damage occurring of his fact, it belongs to him to be assured. The campground declines any responsibility in the event of flight, fire, bad weather etc...
